NOTICE: Many of the Ash trees on our property have been impacted by the Emerald Ash Borer and are in the process of dying or are dead. Branches from these trees or the trees themselves may come down at any time, especially in heavy winds. Please make sure everyone in your group is aware of this situation and that they stay away from all trees at SOC in general at this time. We are making a concerted effort to have these trees removed

All visitors must take extra precaution during periods of heavy wind. If winds are forecasted to exceed 30 MPH and/or if thunderstorms are forecasted, SOC will be closed! If your group is on the premises, they must leave at least 1hr prior to such conditions impacting the site, without exception. Groups will be able to reschedule or receive refunds as appropriate.

The Hunterdon Conservation, Education, Recreation Council Inc. (administrators of the Sauerland Outdoor Center), depends upon youth groups using the Center to have parental permission (the Council does not assume this responsibility) and all groups to provide proof of insurance coverage *naming Hunterdon Conservation Education Recreation Council, Inc., DBA Sauerland Outdoor Center and the State of New Jersey, Department of Environmental Protection, Division of Parks and Forestry, and the New Jersey*
